OPTIONAL SERVICES

Gas Safety Check (GSC)	£36 (Inc VAT) plus cost of the check
Contact the contractor and Tenant and arrange access for the gas check to be carried out. Receive certificate from contractor, send copy to Landlord, retain copy on file, diarise next check for 12 month's time.	

Electrical Check (EICR)	£36 (Inc VAT) plus cost of the check
Contact the contractor and Tenant and arrange access for the electrical check to be carried out. Receive certificate from contractor, send copy to Landlord, retain copy on file, diarise next check.	

Energy Performance Certificate (EPC)	£36 (Inc VAT) plus cost of EPC
Contact the contractor and Tenant if applicable and arrange access for the EPC to be carried out. Receive EPC from contractor, send copy to Landlord, retain copy on file, diarise next EPC for 10 year's time.	

Empty Care Service	£60 (Inc VAT) per visit
To visit the empty property at agreed intervals and report to the Landlord.	

Drain Down Service	£36 (Inc VAT)
To arrange a water system drain down on behalf of the Landlord.	

Re-negotiate rent and serve a Section 13	£120 (Inc VAT)
Review rent in accordance with current prevailing market conditions and advise Landlord. Negotiate with Tenant. Direct Tenant to make payment change as appropriate. Serve Section 13 Notice to Tenant advising of increased rent.	

Draw up and serve Section 21	£120 (Inc VAT)

Change of Tenant (During fixed term contract)	£300 (Inc VAT)

PS&B Attendance at Court	£250 (Inc VAT) per whole day

Management Takeover	£300 (Inc VAT)
Visit property, check paperwork, compliance check - issue new AST.	
Submission of non-resident Landlords	£150 (Inc VAT) annually
receipts to HMRC. To remit and balance the financial return to HMRC quarterly and respond to any specific query relating to the return from the Landlord or HMRC.	

Deposit Dispute Fee	£120 (Inc VAT)
Where PS&B are instructed to progress a Tenancy Deposit dispute via the Tenancy Deposit Scheme	
Rental Warranty 12 month cover with zero Excess	From £330 (Inc VAT)
Sale of Property to a Tenant	1.2% (Inc VAT)
Of the purchase price for introducing the Tenant (the purchaser) to the Landlord (the vendor).
